ORDINANCE

AN ORDINANCE TO AMEND THE 2020 CAPITAL BUDGET TO FUND THE PURCHASE OF COVID-19 TESTING EQUIPMENT IN PARTNERSHIP WITH UNITED HEALTH SERVICES (UHS)

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2020 Capital budget to create a new expense line in the Capital Fund and to transfer funds thereto to fund the purchase of COVID-19 testing equipment in partnership with United Health Services (UHS); and

WHEREAS, the amount of \$70,000 is to be used for expenses to control the spread of COVID-19.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Capital Budget to create a new budget line H1210.525900 (CoronaVirus Expenses) as follows:

- \$70,000 decrease to budget line A49999 (Appropriated Fund Balance) (i)
- \$70,000 increase to budget line A9950.59000 (Transfer to Capital) (ii)
- \$70,000 increase to budget line H.45031 (Interfund Transfer) (iii)
- \$70,000 increase to budget line H1210.525900 (CoronaVirus Expenses) (iv)

That this Ordinance shall take effect upon approval of the Board of Section 2. Estimate and Apportionment
