AN ORDINANCE AMENDING THE 2020 SEWER AND WATER BUDGETS TO FUND THE SERIAL BOND INTEREST DUE TO REFINANCING OF THE 2012 BOND

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2020 Sewer and Water budgets to transfer funds from Serial Bond principal to Serial Bond interest due to refinancing of 2012 the Bond; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on September 30, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:
