RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with CNY FAIR HOUSING, INC. for housing rights and assistance availability education at a cost not to exceed \$15,000 funded through the current Cities Rise III grant and that funds shall be deducted from budget line H1212.555555.M0018 (Cities Rise III) for this purpose.
