A RESOLUTION AUTHORIZING THE MAYOR
TO ACCEPT A GRANT FROM THE UNITED
STATES TENNIS ASSOCIATION (USTA) FOR
TENNIS SUPPLIES AND INSTRUCTORS

WHEREAS, the City of Binghamton is eligible to receive a grant in the amount of \$1,000 from the United States Tennis Association ("USTA") for tennis supplies and instructors; and

WHEREAS, the grant does not require a local match, that the grant will be administered by the Commissioner of Parks and Recreation, or his designee.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, to accept a grant in the amount of \$1,000 from the USTA for tennis supplies and instructors; and be it further

RESOLVED that grant does not require a local match, that the grant will be administered by the Commissioner of Parks and Recreation, or his designee, and posted in revenue budget line H.42705 (Gifts and Donations- Tennis Grant) and expense budget line H7110.55555.PK14 (Tennis Grant 2020) to be expensed in 2020.
