**AN ORDINANCE AMENDING THE 2020
CAPITAL FUND BUDGET FOR THE ZOMBIE
GRANT BENEFITS**

WHEREAS, the Director of Planning, Housing, and Community Development and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Capital Fund budget to create budge lines and to fund benefits not previously funded by the Zombie Grant; and

WHEREAS, the budget transfers were approved by the Board of Estimate and Apportionment on August 19, 2020.
