WHEREAS, the City of Binghamton wishes to enter into an agreement with Salvation Temple Church for use of Fiscal Year 45 Community Development Block Grant funding in an amount not to exceed \$10,500 for capital upgrades to support its local community meals program.

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the Salvation Temple Church for use of Fiscal Year 45 Community Development Block Grant funds in an amount not to exceed \$10,500 for capital upgrades to support its local community meals program, and that funds shall be deducted from budget line CD8662.53552.CDY45 (Human Srvcs Capital Set Aside) for this purpose.
