
A RESOLUTION AUTHORIZING THE MAYOR

CDBG FUNDING IN AN AMOUNT NOT TO
EXCEED \$2,200

WHEREAS, the City of Binghamton wishes to enter into an agreement with the Hands of Hope Ministries of the Free Methodist Church for use of Fiscal Year 45 Community Development Block Grant funding in an amount not to exceed \$2,200 for capital upgrades to support its local community meals program.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the Hands of Hope Ministries of the Free Methodist Church for use of Fiscal Year 45 Community Development Block Grant funds in an amount not to exceed \$2,200 for capital upgrades to support its local community meals program, and that funds shall be deducted from budget line CD8662.53552.CDY45 (Human Svcs Capital Set Aside) for this purpose.
