AN ORDINANCE TO AMEND THE 2020 CAPITAL FUND BUDGET TO CLOSE GRANT LINES THAT ARE NO LONGER ACTIVE

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2020 Capital budget to close bond lines that are no longer active; and

WHEREAS, the budget amendments were approved by the Board of Estimate and Apportionment on August 5, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Capital budget to close bond lines that are no longer active as follows:
