A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT AND USE \$250,000 THROUGH THE DOJ COPS OFFICE TO FUND THE HIRING OF TWO NEWLY APPOINTED OFFICERS FOR A THREE YEAR PERIOD

WHEREAS, the City of Binghamton Police Bureau is eligible to receive a US Department of Justice COPS Grant in the amount of \$250,000; and

WHEREAS, the funds will be used to fund two newly appointed police officers; and

WHEREAS, the grant requires a local match of 25%, the grant funds will be administered by the Chief of Police, or his designee; and the estimated date of completion is June 30, 2023.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, as may be necessary to accept a US Department of Justice COPS Grant for \$250,000; and the Comptroller and City Treasurer of the City of Binghamton are directed to amend the budget accordingly; and be it further

RESOLVED that there is a City match of 25% for the acceptance of such funds and that funds will be deducted from budget line A3120.51000 (Police Personal Wages) for this purpose, the Chief of Police, or his designee, shall be the grant project administrator, and that the estimated date of completion is June 30, 2023.
