RESOLUTION **AUTHORIZING** THE ACCEPTANCE OF 2020 FY BJA CORONAVIRUS **EMERGENCY** SUPPLEMENTAL FUNDING GRANT

WHEREAS, the City of Binghamton is eligible for a BJA FY 2020 Coronavirus Emergency Supplemental Funding Grant in the amount of \$87,502 to be used to fund overtime, reimburse previously purchased and new purchases of personal protection equipment ("PPE") and sanitary needs in order to combat COVID-19 issues; and

WHEREAS, the BJA F 2020 Coronavirus Emergency Supplemental Funding Grant does not require a local match; the grant funds will be administered by the Chief of Police or his designee; and the estimated date of completion will be January 19, 2022.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, as may be necessary to accept a BJA FY 2020 Coronavirus Emergency Supplemental Funding Grant in the amount of \$87,502, and the Comptroller is authorized and directed to amend the budget accordingly; and be it further

RESOLVED that there is no City match for the acceptance of such funds; that the Chief of Police or his designee shall be the grant project administrator; and that the estimated date of completion will be January 19, 2022.
