**AN ORDINANCE TO AMEND THE 2020
PLANNING AND ZONING BUDGET TO ADD A
"HOUSING SAFETY SPECIALIST" POSITION**

WHEREAS, the Director of Planning, Housing and Community Development and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Planning and Zoning budget to add a "Housing Safety Specialist" position from April 13 to December 31, 2020; and

WHEREAS, the "Housing Safety Specialist" position was approved by the Civil Service Commission on February 25, 2020; and

WHEREAS, the "Housing Safety Specialist" position will be funded from the New York State Cities Rise Grant; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on March 25, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Planning and Zoning budget budget to add a "Housing Safety Specialist" position from April 13 to December 31, 2020, to be funded by the New York State Cities Rise Grant as follows:
