A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A PROFESSIONAL SERVICES AGREEMENT WITH BARTON & LOGUIDICE, DPC FOR RECREATION PARK TENNIS COURT UPGRADES AND A PERMANENT LOCATION FOR AN ICE RINK

WHEREAS, the City Engineer recommends the City enter into a Professional Services agreement with Barton & Loguidice, DPC for Recreation Park tennis court upgrades and a permanent location for an ice rink; and

WHEREAS, the total estimated cost for such services is \$135,500; and

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into a Professional Services agreement, approved as to form and content by the Office of Corporation Counsel, with Barton & Loguidice, DPC for (i) Recreation Park tennis court upgrades at a cost of \$117,500, and funds shall be deducted from budget line H7110.525277.12220 (Rec Park Tennis Courts); and (ii) a permanent location for an ice rink at Recreation Park at a cost of \$18,000, and funds shall be deducted from budget line CD8662.533507.CDY44 (Park Improvements), for this purpose.
