A RESOLUTION AUTHORIZING THE MAYOR
TO ENTER INTO AN AGREEMENT WITH GHD
CONSULTING SERVICES INC. FOR THE CSP-
LTCP POST CONSTRUCTION COMPLIANCE
MONITORING PROGRAM AT THE BJCJSTF

WHEREAS, the City Engineer recommends the City enter into an agreement with GHD Consulting Services Inc. for CSP-LTCP Post Construction Monitoring at the Binghamton-Johnson City Joint Sewage Treatment Facilities ("BJCJSTF"); and


WHEREAS, the cost will be \$33,500 (Lab Work), \$2,000 (Equipment), and \$24,250 (Consultant Fee), for a total of \$59,750; and

WHEREAS, the total cost of services will be divided proportionately between the City of Binghamton and the Village of Johnson City; and

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with GHD Consulting Services Inc. for CSP-LTCP Post Construction Monitoring at the BJCJSTF at a cost of \$59,750 and funds shall be deducted from budget line H8120.525055.20619 (Sewer Lines) for this purpose.
