**AN ORDINANCE TO AMEND THE 2019
PARKING RAMPS BUDGET TO INCREASE
MANAGEMENT SERVICES EXPENSES**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2019 Parking Ramps budget to increase Management Services expenses; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 18, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Parking Ramps budget to increase Management Services expenses as follows:

Transfer From (defund/decrease):

\$9,899 CP5650.54202 (Electricity)
2,100 CP5650.54300 (Insurance)

\$11,999


Transfer To (fund/increase):

\$11,999 CP5650.54427 (Management Services)

\$11,999
