AN ORDINANCE TO AMEND THE 2020 CAPITAL BUDGET TO FUND COVID-19 MITIGATION

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2020 Capital budget to create a new expense line in the Capital Fund and to transfer funds thereto for COVID-19 mitigation; and

WHEREAS, the amount of \$50,000 is to be used for expenses to control the spread of COVID-19; and

WHEREAS, the budget amendments were approved by the Board of Estimate and Apportionment on March 18, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Capital Budget to create a new budget line H1210.xxxxx (CoronaVirus Expenses) as follows:

- (i) \$50,000 decrease to budget line A599 (Appropriated Fund Balance)
- (ii) \$50,000 increase to budget line A9950.59000 (Transfer to Capital)
- (iii) \$50,000 increase to budget line H.45031 (Interfund Transfer)
- (iv) \$50,000 increase to budget line H1210.xxxxx (CoronaVirus Expenses)

Section 2. That this Ordinance shall take effect immediately.
