**AN ORDINANCE TO AMEND THE 2019 JT

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2019 JT Sewer Project budget to close lines that are no longer active; and

WHEREAS, the budget amendments were approved by the Board of Estimate and Apportionment on February 19, 2020.

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to close the 2019 JT Sewer Project budget lines that are no longer active as follows:
