A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH BROOME COUNTY FOR GIS SERVICES FOR 2020-2029

WHEREAS, pursuant to Permanent Resolution 08-23, dated March 3, 2008, the City entered into an inter-municipal agreement with Broome County for GIS Services; and

WHEREAS, the term of the agreement expired on December 31, 2019; and

WHEREAS, the City wishes to re-approve and extend the agreement to December 31, 2029 at a cost in 2020 not to exceed \$30,500.

WHEREAS the City of Binghamton and Broome County have the right to opt-out effective January 1st of each year, with a 6 months prior written notice to the Mayor's Office or City of Binghamton IT Department; or to the County Executive's Office or the Broome County Planning Department.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Broome County for GIS Services through December 31, 2029, at a cost in 2020 not to exceed \$30,500; and that funds shall be deducted in 2020 from budget lines: (i) \$16,500 A1680.54420 (Technical Services), (ii) \$7,000 FX8310.54448 (GIS Services), and (iii) \$7,000 CD8684.54448.CDY45 (GIS Services) for this purpose.
