AN ORDINANCE TO AMEND THE 2019 CAPITAL FUND BUDGET TO CLOSE A BOND LINE THAT IS NO LONGER ACTIVE

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2019 Capital budget to close bond lines that are no longer active; and

WHEREAS, the budget amendments were approved by the Board of Estimate and Apportionment on January 22, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:
