**AN ORDINANCE TO AMEND THE 2019 POLICE
BUDGET TO CHANGE SENIOR TYPIST TO
PROGRAM ASSISTANT**

WHEREAS, the Chief of Police and the Director of Personnel and Employee Safety of the City of Binghamton find it proper and necessary to amend the 2020 Bureau of Police budget to remove one "Senior Typist" position with an annual salary of \$33,902; and replace that position with a "Program Assistant" position with an annual salary of \$33,902; and

WHEREAS, the new title was approved by the City of Binghamton Civil Service Commission on January 28, 2020; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 22, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Bureau of Police budget to amend budget line A3120.51000 (Personal Services) to remove one "Senior Typist" position with an annual salary of \$33,902; and to replace that position with a "Program Assistant" position with an annual salary of \$33,902, and to fund the new "Program Assistant" position as follows:

Transfer From (defund/decrease):

\$33,902 A3120.51000 (Per Ser-Senior Typist)

Transfer To (fund/increase):

\$33,902 A3120.51000 (Per Ser-Program Assistant)

Section 2. That this Ordinance shall take effect immediately.
