## **ORDINANCE**

AN ORDINANCE TO AMEND THE 2019 GENERAL FUND BUDGET TO TRANSFER FUNDS TO COVER VARIOUS OVER-BUDGET LINES

WHEREAS, the Comptroller finds it proper and necessary to amend the 2019 General Fund budget to transfer funds to cover various over-budget lines; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on February 5, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 General Fund budget transfer funds to cover various over-budget lines
