## **ORDINANCE**

AN ORDINANCE TO AMEND THE 2019 GENERAL FUND AND CAPITAL BUDGETS FOR NYSEG STADIUM

WHEREAS, the Comptroller finds it proper and necessary to amend the 2019 General Fund and Capital budgets for NYSEG Stadium; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on February 5, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 General Fund and Capital budget for NYSEG Stadium as follows:

- i) \$31,560.61 decrease in budget line A9060.58000C (Health Insurance)
- ii) \$31,560.61 increase to budget line A9950.59000 (Transfer to Capital)
- iii) \$31,560.61 increase to revenue to Capital budget line H.45031 (Interfund Transfer)
- iv) \$31,560.61 increase expense budget line H1310.525209 (NYSEG Stadium Facility Improvement)

Section 2. That this ordinance shall take effect immediately.
