WHEREAS, the City of Binghamton wishes to enter into an agreement with CNY FAIR HOUSING, INC. to perform an update to the Analysis Impediments to Fair Housing at a cost not to exceed \$15,000; and,

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with CNY FAIR HOUSING, INC. to perform an update to the Analysis Impediments to Fair Housing at a cost not to exceed \$15,000 and that funds shall be deducted from budget lines \$7,000 - CD8686.533528.CDY42 (Admin) and \$8,000 - CD8684.533535.CDY45 (Home Market Analysis) for this purpose.
