## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2020 FEE SCHEDULE TO ADD A FEE FOR A PRE-ADOPTION (BIRTH) CERTIFICATE **PURSUANT** TO PUBLIC HEALTH LAW SECTION 4138-E

WHEREAS, Public Health Law § 4138-E (PHL § 4138-E), effective January 15, 2020, allows adoptees, eighteen years of age or older, adoptee direct line descendants, and/or the legal representatives to either the adoptee or the direct line descendants, to receive a copy of their Preadoption (birth) Certificate (PAC); and

WHEREAS, PHL § 4138-E, further provides that the local filing office is entitled to collect a nominal fee for a PAC; and

WHEREAS, New York State charges \$30 for a birth certificate and an additional nominal fee of \$15 for a PAC, a total fee of \$45; and

WHEREAS, the City of Binghamton charges \$10 for a birth certificate and wishes to charge an additional nominal fee of \$12 for a PAC, a total fee of \$22, consistent with its fee for a Genealogical Search; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 15, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Fee Schedule to add a fee for a Pre-adoption *(birth) Certificate (PAC)* as follows:
