## **ORDINANCE**

AN ORDINANCE TO AMEND THE 2019 PARKS DEPARTMENT BUDGET TO ENCUMBER A DICK'S \$10,000 DONATION FROM THE SPORTING GOODS FOUNDATION TO BE EXPENSED IN 2020

WHEREAS, pursuant to Permanent Ordinance O19-099, dated September 4, 2019, the City accepted a donation from the Dick's Sporting Goods Foundation in the amount of \$10,000 for the Parks Department's Youth Programs to purchase athletic supplies; and

WHEREAS, given the time of the donation, the Parks Department did not expend the funds in 2019, and requests that the 2019 donation be encumbered in the 2019 Youth Programs budget so it can be expensed in 2020; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 22, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 budget to encumber a donation from the Dick's Sporting Goods Foundation in the amount of \$10,000 posted in revenue line A.42705 (Gifts and Donations) and Youth Programs budget expense line A7310.54161 (Athletic Supplies) to be expensed in 2020.

Section 2. That this Ordinance shall take effect immediately.
