**AN ORDINANCE TO AMEND THE 2019 DPW
BUDGET TO PAY THE DECEMBER TIPPING
FEE**

WHEREAS, the Commissioner of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2019 Refuse Disposal budget to pay the December 2019 tipping fee; and

WHEREAS, the budget amendment was approved by the Board of Estimate and Apportionment on January 22, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2019 Department of Refuse Disposal budget to pay the December 2019 tipping fee as follows:

Transfer From (Decrease):

\$20,000 CL9060.58000C (Health Ins.)
4,630 CL9030.58000B (Social Security)

\$24,630


Transfer To (Increase):

\$24,630 CL8160.54661(Tipping fee)

\$24,630
