AN ORDINANCE TO AMEND THE 2020 BUREAU OF POLICE BUDGET TO ADD AN ADMINISTRATIVE ASSISTANT

WHEREAS, the Chief of Police and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 budget to create an additional "Administrative Assistant" position in the Bureau of Police budget to provide discovery services as required by changes in New York State law; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on January 8, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 budget to create an additional "Administrative Assistant" position in the Bureau of Police, budget line A3120.51000 (Personal Services), at an annual salary of \$42,000 with a 40 hour work week and to transfer funds for this position as follows:
