AN ORDINANCE TO AMEND THE 2020 CODE ENFORCEMENT BUDGET TO CHANGE THE TITLE OF "ASSISTANT SUPERVISOR OF BUILDING AND CONSTRUCTION" TO "ASSISTANT SUPERVISOR OF BUILDING CONSTRUCTION & CODE ENFORCEMENT"

WHEREAS, the Supervisor of Building Inspection and Construction and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Code Enforcement budget to correct the Assistant Supervisor's title in budget line A8664.51000 (Personal Services); and

WHEREAS, such amendment was approved by the Board of Estimate and Apportionment on January 8, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Code Enforcement budget, budget line A8664.51000 (Personal Services), to amend the "Assistant Supervisor Building and Construction" title to "Assistant Supervisor of Building Construction & Code Enforcement" with a 40 hour work week.

Section 2. That this Ordinance shall take effect immediately.
