**ORDINANCE**

AN ORDINANCE TO AMEND THE 2020 ASSESSOR'S BUDGET TO REMOVE THE "REAL PROPERTY DATA MAINTENANCE ASSISTANT" POSITION AND REPLACE WITH "REAL PROPERTY TAX AIDE"

WHEREAS, pursuant to Permanent Ordinance O19-126, dated December 4, 2019, City Council approved an amendment to the 2019 Assessment budget to remove the "Real Property Data Maintenance Assistant" position and replace that position with a "Real Property Tax Aide"; and

WHEREAS, the Assessor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Assessment budget to be consistent with Permanent Ordinance O19-126; and

WHEREAS, such amendment was approved by the Board of Estimate and Apportionment on January 8, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Assessment budget to remove the "Real Property Data Maintenance Assistant" position and replace that position with a "Real Property Tax Aide" at an annual salary of \$30,333, and to transfer excess funds to contingency as follows:
