DECISION & ORDER

Re: Suspension of Working Master Electrician's License, Class A, and Journeyman's License

Mr. Faber,

On January 6, 2021, the City of Binghamton Board of Electrical Examiners held a hearing to consider suspension of your Working Master Electrician's License, Class A, and Journeyman's License. In addition to the Board, the hearing was attended by yourself. The Board heard evidence on the below charges:

Violating the City of Binghamton Charter and Code of Ordinances, sections § 225-6.F, Failure to obtain and maintain Worker's Compensation Insurance and § 225-6, Installing, altering or repairing, electrical wiring in the City without a permit and § 225-31.A, Violating City of Binghamton Charter and Code of Ordinances and New York State Worker's Compensation Law.

DECISION


Based upon the evidence presented, the Board finds that Scott Faber, as agent and/or principal for CDR Electric LLC, violated the above codes as follows:

On September 29, 2020, Scott Faber, as agent and/or principal for CDR Electric LLC failed to provide proof of workers' compensation insurance to the City of Binghamton Building Construction Department for work performed at 79 Collier St. Binghamton, NY.

From September 10, 2020 until January 6, 2021, Scott Faber, as agent and/or principal for CDR Electric LLC installed, altered or repaired, electrical wiring and/or or performed other duties in the capacity of an electrician at 79 Collier St. Binghamton, NY, without filing a complete and proper application and obtaining an Electrical Permit from the City of Binghamton Building Construction Department.

The Board hereby suspends your Working Master Electrician's License, Class A, and your Journeyman's License for one (1) year from the date of this letter. Scott Faber, as agent and/or principal for CDR Electric LLC, shall not install, alter or repair, or cause to be installed, altered or repaired, any electrical wiring or perform any duties in the capacity of an electrician in the City of Binghamton.

Failure to comply with this order gives the Board of Electrical Examiners the right to put these violations back on the agenda for review, which could result in the permanent revocation of you licenses.
