ORDINANCE

entitled **ORDINANCE** AMENDING THE 2021 SENIOR CENTER BUDGET TO REMOVE ONE REC ATTENDANT AND ADD ONE SENIOR

CITIZENS CENTER CUSTODIAN

WHEREAS, the Commissioner of Parks and Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 Senior Center budget to remove one "Rec Attendant" and add one "Senior Citizens Center Custodian" at an annual salary of up to \$13,000.00; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on June 23, 2021, and adopted by the Civil Service Commission on April 21, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Senior Center budget to (i) defund budget line A7620.51800 (Rec. Attendant @ 12.50/hr x 4hrs/day x 5days/wk = 1.00 @ 13,000.00) and (ii) to add one Senior Citizens Center Custodian at an annual salary of up to \$13,000 (@ 12.50/hr).

Section 2. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Senior Center budget to transfer funds for the new Senior Citizens Center Custodian position from June 28 through December 31, 2021, as follows:

<u>Transfer From (Decrease):</u> \$6,377.15 A7620.51800 (Rec. Attendant) Transfer To (Increase):

\$6,377.15 A7620.51800 (Sen. Cit. Center

Custodian @ 12.50/hr)

Section 3. That this ordinance shall take effect June 28, 2021.
