**AN ORDINANCE TO AMEND THE 2021 DPW  
BUDGET TO FUND ADDITIONAL VEHICLE  
PARTS AND REPAIRS**

WHEREAS, the Commissioner of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 DPW budget to transfer funds for additional vehicle parts and repairs; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on July 14, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 DPW budget for additional vehicle parts and repairs as follows:

Transfer From (Decrease):

\$30,000 A5142.51800 (Temp.Ser.)

\$30,000

Transfer To (Increase):

\$20,000 A1640.54110 (Vehicle Parts)  
\$10,000 A1640.54450 (Vehicle Repairs)

\$30,000

Section 2. That this Ordinance shall take effect immediately.
