**AN ORDINANCE TO AMEND THE 2021 DPW
BUDGET TO INCREASE FUNDING FOR THE
SUPERVISOR POSITION**

WHEREAS, the Commissioner of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 DPW budget to transfer funds for the supervisor position upon retirement of the current supervisor; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on July 14, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 DPW budget to transfer funds for the supervisor position upon retirement of the current supervisor as follows:

Transfer From (Decrease):

Transfer To (Increase):

\$22,082.87 A1650.51000 (Per.Ser-St.Maint.
Sup.)

Section 2. That this Ordinance shall take effect immediately.
