AN ORDINANCE AMENDING THE 2021 TREASURER BUDGET FOR STIPENDS FOR ADDITIONAL RESPONSIBILITIES OF THE PRINCIPAL CLERK AND AN ACCOUNT CLERK II

WHEREAS, the Treasurer and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 Treasurer budget to provide a stipend for additional responsibilities assigned to the Principal Clerk and Account Clerk II [\$34,849]; and

WHEREAS, funds are available for this purpose from the existing Temporary Services budget lines; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on July 14, 2021.
