## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2021 GENERAL FUND AND CAPITAL BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR COUNCIL CHAMBERS CEILING AND ROOF REPAIRS/REPLACEMENT

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 General Fund and Capital budget to (i) create an expense line for roof and ceiling repairs/replacements to Council chambers to provide necessary meeting space and (ii) allocate American Rescue Plan Act (ARPA) funds for same in the amount of \$659,000; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on July 21, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 General Fund and Capital budget to (i) create expense budget line H1620.525004 (City Hall Improvements) for roof and ceiling repairs/replacements to Council chambers to provide necessary meeting space and (ii) allocate ARPA funds for same in the amount of \$659,000 as follows:

- (i) \$659,000 increase revenue budget line A.44089.F0015 (Fed.Aid.-Other)
- (ii) \$659,000 increase expense budget line A9950.59000.F0015 (Transfer to Capital)
- (iii) \$659,000 increase revenue budget line H.45031 (Interfund Transfer)
- (iv) \$659,000 increase expense budget line H1620.525004 (City Hall Improvements)

Section 2. That this Ordinance shall take effect immediately.

I HEREBY CERTIFY that the above described funds are unencumbered and available
