

ORDINANCE

entitled

AN ORDINANCE TO AMEND THE 2021 MAYOR BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR ADDITIONAL CORONAVIRUS EXPENSES

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 Mayor budget to (i) create an expense line for City Hall coronavirus expenses and (ii) allocate American Rescue Plan Act (ARPA) funds for same in the amount of \$25,000; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on July 21, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Mayor budget to (i) create expense budget line A1210.525900.F0015 (Mayor-Coronavirus Expense) for City Hall coronavirus expenses and (ii) allocate ARPA funds for same in the amount of \$25,000 as follows:
 - \$25,000 increase to revenue budget line A.44089.F0015 (Federal Aid-Other) (i)
 - \$25,000 increase to expense budget line A1210.525900.F0015 (Mayor-Coronavirus (ii) Expense)

Section 2. That this Ordinance shall take effect immediately.
