An award recommendation for the bid for 2021 Binghamton Fire Department (Electrical) the bid bind bond was reject from apparent low bidder Huen on a motion for Mr. Frank and seconded by Mr. Shager and unanimously favored. The second lowest bidder, Upstate Company, at a bid price of \$898,000.00 was approved on a motion by Mr. Shager and seconded by Mr. Lake and unanimously favored. Funds are available in H3410.525326.72720.
