

ORDINANCE

AN ORDINANCE TO AMEND THE 2021 ENGINEERING BUDGET FOR PERSONAL **SERVICES**

WHEREAS, the City Engineer and Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 Engineering budget to defund the Senior Account Clerk Typist position and fund the Engineering Technician position at an annual salary of up to \$41,477; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on August 4, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Engineering budget to defund the Senior Account Clerk Typist position and fund the Engineering Technician position at an annual salary of up to \$41,477.

That the Comptroller and City Treasurer of the City of Binghamton are Section 2. hereby authorized and directed to amend the 2021 Engineering budget to fund the Engineering Technician position from August 9 through December 31, 2021, as follows:
