AN ORDINANCE AMENDING THE 2021 BUDGET TO ALLOCATE AMERICAN RESCUE PLAN ACT FUNDS FOR DEVELOPMENT OF AFFORDABLE HOUSING BY THE FIRST WARD ACTION COUNCIL

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 budget to allocate American Rescue Plan Act (ARPA) funds for development of affordable housing by the First Ward Action Council; and

WHEREAS, estimated cost for such services is not to exceed \$355,000; and

WHEREAS, pursuant to Permanent Resolution 21-57, dated July 21, 2021, City Council approved a resolution authorizing the Mayor to enter into an agreement with the First Ward Action Council for use of CVY46 funds to support affordable housing development, at a cost not to exceed \$80,000; and

WHEREAS, the City wishes to void Permanent Resolution 21-57; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on August 4, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That Permanent Resolution 21-57 is hereby declared null and void.
- Section 2. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 budget to allocate American Rescue Plan Act (ARPA) funds for development of affordable housing by the First Ward Action Council, in an amount not to exceed \$355,000 as follows:
 - (i) \$355,000 increase revenue budget line A.44089.F0015 (Federal Aid-Other)
 - (ii) \$355,000 increase expense budget line A8686.XXXXXX.F0015 (Affordable Housing)

Section 3. That this ordinance shall take effect on August 4, 2021.
