ORDINANCE

entitled

AN ORDINANCE TO AMEND THE 2021 GENERAL FUND AND CAPITAL BUDGET FOR THE PURCHASE OF TWO AMBULANCES

WHEREAS, the Fire Chief and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 General Fund and Capital budget for the purchase of two (2) ambulances; and

WHEREAS, the price of each ambulance is \$125,000, and the City wishes to trade-in two older ambulances for a price-reduction of \$10,000 per ambulance; and

WHEREAS, the price of each ambulance with the trade-in is \$115,000; and

WHEREAS, the total cost for two ambulances is not to exceed \$230,000; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on August 11, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 General Fund and Capital budget for purchase of two ambulances as follows:

- (i) \$230,000 increase revenue budget line A.49999 (Fund Balance)
- (ii) \$230,000 increase expense budget line A9950.59000 (Transfer to Capital)
- (iii) \$230,000 increase revenue budget line H.45031 (Interfund Transfer)
- (iv) \$230,000 increase expense budget line H3410.525082 (Fire-Ambulances)

Section 2. That this Ordinance shall take effect immediately.
