**AN ORDINANCE TO AMEND PERMANENT
ORDINANCE 20-92 TO REINSTATE SECTION B
TO CHAPTER 26, CITY COUNCIL, § 26-12,
ANNUAL SALARY**

WHEREAS, pursuant to Permanent Ordinance 20-92, dated October 21, 2020, City Council amended Chapter 26, *City Council*, Section 26-12, *Annual Salary*, to provide for the annual salary for 2021 in subsection A; and

WHEREAS, subsection B was inadvertently deleted in such legislation.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That Permanent Ordinance 20-92, is hereby amended to correct the Section 1 as follows: That the Code of the City of Binghamton, Chapter 26, *City Council*, § 26-12.A, *Annual Salary*, is deleted in its entirety and is replaced as follows:

1. From January 1, 2021, through December 31, 2023, the annual salary of each of the members of the Common Council of the City of Binghamton shall be \$10,160.

Section 2. That Section B is reinstated in its entirety.

Section 3. That this ordinance shall take effect immediately.

PERSONNEL POLICIES, OF THE CODE OF THE
CITY OF BINGHAMTON, TO ADD TWO
POSITIONS TO THE LIST OF 8 HOUR PER
STANDARD WORK DAY EMPLOYEES

WHEREAS, the Council of the City of Binghamton wishes to amend the Code of the City of Binghamton, Chapter 124, *Personnel Policies*, Article VIII, *Officers and Employees not covered by Collective Bargaining Agreements*, §124-39.A, *Standard Work Day*, to add two (2) positions.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Code of the City of Binghamton, Chapter 124, *Personnel Policies*, Article VIII, *Officers and Employees not covered by Collective Bargaining Agreements*, §124-39.A, *Standard Work Day*, is hereby amended to add to the list of 8 hour per standard work day employees as follows:

- (i) City Clerk
- (ii) Deputy City Clerk

Section 2. That this ordinance shall take effect immediately.
