AN ORDINANCE TO AMEND PERMANENT ORDINANCE 20-92 TO REINSTATE SECTION B TO CHAPTER 26, CITY COUNCIL, § 26-12, ANNUAL SALARY

WHEREAS, pursuant to Permanent Ordinance 20-92, dated October 21, 2020, City Council amended Chapter 26, City Council, Section 26-12, Annual Salary, to provide for the annual salary for 2021 in subsection A; and

WHEREAS, subsection B was inadvertently deleted in such legislation.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That Permanent Ordinance 20-92, is hereby amended to correct the Section 1 as follows: That the Code of the City of Binghamton, Chapter 26, City Council, § 26-12.A, Annual Salary, is deleted in its entirety and is replaced as follows:

- From January 1, 2021, through December 31, 2021, the annual salary of each of the members of the Common Council of the City of Binghamton shall be \$10,160.
- Section 2. That Section B is reinstated in its entirety.
- Section 3. That this ordinance shall take effect immediately.
