AN ORDINANCE TO AMEND THE 2021
BUDGET TO ALLOCATE AMERICAN RESCUE
PLAN ACT FUNDS FOR BROADBAND
IMPROVEMENTS WITH THE SOUTHERN TIER
NETWORK

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 budget to (i) create expense budget lines for broadband improvements with the Southern Tier Network and (ii) allocate American Rescue Plan Act (ARPA) funds in the amount of \$1,000,000 for same; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on September 1, 2021.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 budget to (i) create expense budget lines for broadband improvements with the Southern Tier Network and (ii) allocate American Rescue Plan Act (ARPA) funds from A688 (Other Liabilities) in the amount of \$1,000,000 for same as follows:

- (i) \$1,000,000 increase revenue budget line A.44089.F0015 (Federal Aid-Other)
- (ii) \$1,000,000 increase expense budget line A9950.59000.F0015 (Transfer to Capital)
- (iii) \$1,000,000 increase revenue budget line H.45031.F0015 (Interfund Transfer)
- (iv) \$1,000,000 increase expense budget line H1440.525801.F0015 (Broadband Improvements-ARPA)

Section 3. That this ordinance shall take effect immediately.
