**AN ORDINANCE TO AMEND THE 2021 DPW
BUDGET FOR ADDITIONAL FUNDS FOR

WHEREAS, the Commissioner of Public Works and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 DPW budget for additional funds for vehicle repairs and parts; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on September 1, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 DPW budget for additional funds for vehicle repairs and parts as follows:

Transfer From (Decrease):



\$14,970
