AN ORDINANCE TO AMEND THE 2021 BUDGET TO USE FUND BALANCE AND ARPA FUNDS TO REDUCE THE COST ASSOCIATED WITH THE NEW COMMUNITY CENTER AND PARK IMPROVEMENTS AT COLUMBUS PARK

WHEREAS, the Mayor, Acting Commissioner of Parks and Recreation, and Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 budget to use fund balance and ARPA funds to reduce the cost associated with building the new Community Center and park improvements at Columbus Park; and

WHEREAS, the expected total project cost is \$7,200,000, to be paid (i) \$1,100,000 from CDBG funds, (ii) \$3,000,000 from fund balance, and (iii) the remaining \$3,100,000 from American Rescue Plan Act (ARPA) funds; and

WHEREAS, to accomplish these allocations the 2021 budget must be amended to (i) transfer \$3,000,000 from fund balance to the Community Center and Columbus Park, (ii) create expense budget lines for the Community Center and Columbus Park for ARPA funds, and (iii) allocate ARPA funds in the amount of \$3,100,000 for same.

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on September 1, 2021, and September 22, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 budget to (i) transfer \$3,000,000 from fund balance to the Community Center and Columbus Park, (ii) create expense budget lines for the Community Center and Columbus Park for ARPA funds, and (iii) allocate ARPA funds in the amount of \$3,100,000 as follows:

- (i) \$3,000,000 decrease the Fund Balance
- (ii) \$3,000,000 increase expense budget line A9950.59000 (Transfer to Capital)
- (iii) \$3,000,000 increase revenue budget line H.45031 (Interfund Transfer)
- (iv) \$3,000,000 increase expense budget line H7110.525800 (Community Center-Columbus Park)
- (v) \$3,100,000 increase revenue budget line A44089.F0015 (Federal ARPA Revenue)

AN ORDINANCE AMENDING THE CODE OF THE CITY OF BINGHAMTON, CHAPTER 26, CITY COUNCIL, TO REGULATE AND PROVIDE FOR PUBLIC COMMENT AT MOST BUSINESS MEETINGS

WHEREAS, the Council of the City of Binghamton wishes to amend the City Code to regulate and provide for public comment at most business meetings.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Code of the City of Binghamton, Chapter 26, *City Council*, is hereby amended as follows:

§ 26-5. Rules adopted. [Amended 10-5-1992 by Ord. No. 92-92; 2-6-1995 by Ord. No. 10-95; 6-1-1998 by Ord. No. 98-57; 7-20-1998 by Ord. No. 98-107; 12-21-1998 by Ord. No. 98-172; 1-19-1999 by Ord. No. 99-4; 12-17-07 by Ord. No. 57-2007; 2-4-08 by Ord. No. 11-2008; 4-5-2017 by Ord. No. 17-26; **Amended 9-22-21 by Ord. No.** \_\_\_\_\_]

### B. [New] Business Meetings.

(1) Order of business. Except as set forth in (2) and (3) below, the order of business at a regularly scheduled business meeting, which shall not in any case be departed from unless by the unanimous consent of the members of City Council present, shall be as follows:

- (2) At a special business meeting with pending legislation to be voted upon the order of business shall be as follows:
  - I. Call to Order
  - II. Pledge of Allegiance
  - III. Roll call
  - IV. Public comment/communication related to the pending legislation only
  - V. Business specified in the notice of meeting, must include legislation to be voted upon
  - VI. Adjournment

- (3) For all other special business meetings where no legislation is to be voted upon, e.g., City Council Organizational meeting, State of the City, and the Mayor's presentation of the annual budget, the order of business shall be as follows:
  - I. Call to Order
  - II. Pledge of Allegiance
  - III. Roll call
  - IV. Business specified in the notice of meeting, no legislation will be on the agenda for a vote
  - V. Adjournment

### O. [New] Members of public addressing City Council and attendance at meetings.

- (1) Public Comment is permitted at all City Council business meetings in which there is pending legislation to be voted upon, see § 26-5 B(1) and (2) above. Public comment is not permitted at a business meeting where no legislation is to be voted upon, see § 26-5 B(3) above, or at work sessions and committee meetings. Public comment is subject to the following rules:
  - (a) Speakers must provide their name and any organization they are representing, if any; and state (i) if they live in the City, (ii) work in the City, (ii) live and work in the City, or (iv) do not live or work in the City. Speakers may include a home or work address at the speaker's discretion.
  - (b) Speakers will appear in person, unless in person meetings are suspended by New York State. If a person wishes to submit public comment but is unable to attend a meeting in person, they may submit a letter or email to the City Clerk no later than 1 pm on the day of the meeting. The letter or email should provide a name and any organization they are representing, if any; and state (i) if they live in the City, (ii) work in the City, (ii) live and work in the City, or (iv) do not live or work in the City. The letter or email will be distributed to members of Council. The letter will be included in the record. The letter may be read by any member of City Council during the public comment period.
  - (c) Speakers will have up to five (5) minutes to address City Council regarding pending legislation and issues affecting the City.
  - (d) Public comment is not a question and answer period. It is an opportunity for the public to address City Council. Members of Council should not interrupt speakers.
  - (e) Speakers will conduct themselves in a professional and respectful manner and they will not defame, intimidate, make personal affronts, make threats of violence, or use profanity.
  - (f) Speakers will address their remarks to City Council, not to other members of the public nor City staff.
  - (g) Speakers and attendees will not interfere with, touch, manipulate, or disturb City equipment, including microphones and audio visual equipment, nor will they move tables or barriers.
  - (h) Speakers and attendees are not permitted to advance beyond the table designated for public comment without the consent of the Presiding Officer.

Any time a "Point of Order" is raised and pending resolution of the "Point of Order," the speaker's microphone will be turned off, if possible. The time to raise and resolve a "Point of Order" will be deducted from the speakers five minutes, unless it is determined that the speaker did not violate the rules.

If violations continue by other persons, in addition to the above procedure, then any member of Council, including the Presiding Officer, may again raise a "Point of Order" and ask for a vote to end public comment for that meeting, and if passed by a majority vote public comment will be terminated.

**EE. [New] Work Sessions and Committee Meetings.** The Presiding Officer at a work session is the President or President Pro Tem. The Presiding Officer at a committee meeting is the Chair of that committee. The Presiding Officer will conduct the meeting. While the Presiding Officer or City Clerk may prepare an agenda, other items may be presented if permitted by the Presiding Officer. Members of City Council will appear in person or otherwise comply with the Open Meetings Law. City employees, consultants, and other invited guests making a presentation may be permitted to appear remotely with consent of the Presiding Officer. There is no public comment at a work session or a committee meeting.

WHEREAS, the City received an Offer to Purchase the Premises from Greater Opportunities for Broome Inc. (the "Applicant"), for \$1 for use of the Premises as a parking lot for the newly renovated affordable housing development units at its adjacent property at 39-49 Munsell Street, Binghamton, New York; and

WHEREAS, the Board of Estimate and Apportionment approved and recommended sale of the Premises on September 22, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain by at least a three-fourths vote as follows:

- Section 1. That the Mayor of the City of Binghamton is hereby authorized to enter into a contract of sale and to execute all necessary and appropriate documentation, approved as to form and content by the Office of Corporation Counsel, to transfer the Premises to Greater Opportunities for Broome Inc., by Quitclaim Deed for \$1 to be paid by cash, certified, or local bank check.
- Section 2. This transfer is subject to the following conditions (i) the Premises may only be used as a parking lot for housing located at 39-49 Munsell Street and (ii) the Premises must be merged with the Applicant's adjacent property located at 39-49 Munsell Street, Binghamton, New York, Tax Parcel No. 144.83-1-22.

### LOCAL LAW NO. 1 OF 2021

A LOCAL LAW AMENDING THE CHARTER OF THE CITY OF BINGHAMTON, CHAPTER 13, ELIGIBILITY, REGARDING RESIDENCY REQUIREMENTS FOR CITY OF BINGHAMTON EMPLOYEES

WHEREAS, the City Charter § C-13, *Eligibility*, provides that no person shall be eligible for appointment to a City office or as a City employee, unless, at the time of his or her appointment, he or she is a bona fide resident of the City of Binghamton, unless the Municipal Civil Service Commission of the City of Binghamton waive the residence requirements set forth; and

WHEREAS, the Municipal Civil Service Commission of the City of Binghamton has recommended that this restriction be eliminated for non-elected employees; and

WHEREAS, the Council of the City of Binghamton wishes to amend § C-13 to provide that applicants residing Broome County will no longer need a waiver if there are no such applicants eligible that reside in the City of Binghamton; and

WHEREAS, the Council of the City of Binghamton wishes to (i) amend § C-13, first paragraph, (ii) replace section A, and (iii) to delete in their entirety sections B, C, and D.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Charter of the City of Binghamton, § C-13, *Eligibility*, is hereby amended as follows:

AN ORDINANCE AUTHORIZING THE SALE OF 7 HARRISON STREET TO ROGER T. HOWE FOR \$53,000

WHEREAS, the City of Binghamton is the owner of certain real property located at 7 Harrison Street, Binghamton, New York, Tax Parcel No. 159.35-3-1 (the "Premises"); and

WHEREAS, pursuant to Permanent Resolution 20-03, dated February 5, 2020, City Council approved to receive a grant from Enterprise Community Partners in the amount of \$585,000 for the Cities RISE innovation program; and

WHEREAS, this property has been brought to code compliance as part of the Cities RISE Program and is ready to sell; and

WHEREAS, the City has no public use for the Premises; and

WHEREAS, the Assessor of the City of Binghamton has determined the sale price to be fair and equitable; and

WHEREAS, the Board of Estimate and Apportionment approved and recommended sale of the Premises on September 15, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain by at least a three-fourths vote as follows:

Section 1. That the Mayor of the City of Binghamton is hereby authorized to enter into a contract of sale and to execute all necessary and appropriate documentation, approved as to form and content by the Office of Corporation Counsel, to transfer the Premises to Roger T. Howe, by Quitclaim Deed for \$53,000 to be paid by cash, certified, or local bank check.

Section 2. This transfer is subject to the conditions in the attached contract of sale.

Section 3. That this Ordinance shall take effect immediately.

### Contract of Sale

THIS CONTRACT OF SALE dated as of the day of November, 2020, by and between the City of Binghamton, a municipal corporation, City Hall, 38 Hawley Street, Binghamton, New York 13901 ("Seller"), and ROGER T. HOWE ("Purchaser").

#### WITNESSETH:

WHEREAS, the Seller owns certain real property located at 7 Harrison Street, Binghamton, New York, Parcel ID Number: 159.35-3-1 (the "Premises"); and

WHEREAS, the Seller is willing to sell the Premises and the Purchaser is willing to purchase a portion of the Premises, upon the terms and conditions herein.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties agree as follows:

- l. <u>Sale and Purchase</u>. The Seller agrees to sell and convey, and the Purchaser agrees to purchase a portion of the Premises. Purchaser will pay for an obtain a survey and the description will be included in the deed.
- 2. <u>Purchase Price</u>. The purchase price for the Premises is FIFTY THREE THOUSAND AND 00/100 (\$53,000), to be paid at the time of the closing by certified or bank funds.
- 3. Contingencies. The Purchaser's obligations herein are contingent on the following:
- 3.1 Within sixty (60) days from the date hereof, receipt of a mortgage commitment from a commercial lender for not more than ONE HUNDRED FIFTY (150) % of the purchase price.
- 3.2 Within sixty (60) days from the date hereof, a satisfactory real property inspection, which may include inspections for infestation and radon Purchaser is relying solely on its own inspection and investigation to determine whether to purchase the Premises. Purchaser is accepting the Premises in its "AS IS" condition. Seller makes no representations or warranties regarding the condition of the Premises or any information supplied to or reviewed by Purchaser.
- 3.3 Within sixty (60) days from the date hereof, a satisfactory title report. Seller may, but is not obligated to correct any title issues. See 6 below.
- 4. <u>Subject to Provisions</u>. The Premises are to be transferred subject to the following:
- 4.1 Such state of facts as an accurate survey or personal inspection may disclose, provided the same does not render title unmarketable.
- 4.2 Rights of the public in and to that portion of the Premises lying within the bounds of any public street or highway.
- 4.3 Covenants, restrictions and easements, if any, of record, provided they are not violated by the existing use of the Premises.

- 4.4 Standard exceptions contained in the form of fee title insurance policy issued by the title insurance company insuring Purchaser's title to the Premises.
- 4.5 Zoning, building, and other ordinances and regulations, if any, provided they are not violated by the existing use.
- 4.6 Special Conditions. The Premises are being conveyed as part of the CITIES RISE program. As a result, these special conditions apply to this transfer:
- 4.6 Special Condition. The Premises are being conveyed as part of the Cities Rise Neighborhood Stabilization Program. As a result, this special condition applies to this transfer: The Premises must be occupied as the Purchaser's primary residence for not less than five (5) years from the date of transfer (the "Recapture Period'). If the Premises or any part thereof is sold, leased, the Purchaser fails to reside at the Premises as Purchaser's primary residence (not less than eleven (11) months per year), or otherwise transfers any interest in the Premises during the Recapture Period, or if Purchaser fails or refuses to provide information so Seller can verify compliance, then Purchaser will pay Seller the amount of FIFTY FOUR THOUSAND EIGHT HUNDRED NINETY-FIVE AND 00/100 (\$54,895), representing the difference between the fair market value of the Premises and the purchase price herein. Such payment will be made to Seller within ten (10) days from the date of written demand for same. In any action or proceeding to enforce this provision, the prevailing party will be entitled to the costs and expenses of such proceeding, including reasonable attorney's fees. This provision will survive the closing of title.
- 5. Adjustments. Water/Sewer and Taxes, if any, will be adjusted as of the Closing date.
- 6. <u>Title to be Conveyed and Deed</u>. The transfer shall be by a Quit Claim Deed. If Purchaser is unable to obtain title insurance insuring good and marketable title to the Premises, then Purchaser may cancel this Contract. Seller may, at its sole cost and expense and prior to closing, cure any title defects, including by way of title endorsement.
- 7. <u>Closing, Transfer of Title and Construction</u>. Transfer of title shall occur on or about sixty (60) days from the date hereof. The closing will take place at City Hall, 38 Hawley Street, Binghamton, New York, at a mutually convenient time; or at a location in Broome County selected by the Mortgagee (i.e., a commercial lender).
- 8. <u>Transfer Tax and Recording Fees</u>. At the closing Purchaser shall deliver a check to the order of the recording officer of Broome County for the amount of the New York State and Broome County transfer tax, documentary stamps, if any. Purchaser shall pay all recording fees.
- 9. <u>Broker</u>. Seller and Purchaser represent to one another that no broker was involved in this transaction. The parties agree to indemnify and hold each other harmless against any and all costs and expenses, including reasonable attorney's fees, by any broker claiming that he/she represented the other party. This paragraph will survive the closing of title.

- 10. Risk of Loss. General Obligations Law Section 5-1311 establishes the risk of loss and obligation of the parties in the event of the destruction or taking by eminent domain of all or a portion of the Premises being conveyed prior to closing.
