### FIRST ORDER OF BUSINESS: APPROVAL OF MINUTES:

### SECOND ORDER OF BUSINESS: BID OPENING:

Bids were received for Broad Ave, Murray St and Schubert St Sanitary Sewer Replacements 2021-25. Five bids were received, were read and forwarded to the Engineering Department on a motion by Mr. Shager and seconded by Mr. Lake and unanimously favored.

### THIRD ORDER OF BUSINESS: AWARD RECOMMENDATION:

An award recommendation for the RFP for Underwater Inspection and Repair of Raw Water Traveling Screens was awarded to the lowest bidder, Coastal Engineering, at a bid price of \$4,900.00/day on a motion by Mr. Seachrist and seconded by Mr. Lake and unanimously favored. Funds are available in H8320.525102.

An award recommendation for the bid for Hydrofluosilicic Acid (HFS), the bid was rejected from apparent low bidder, Univar Solutions USA, Inc., due to non-compliance with the terms and conditions of the bid requirements on a motion for Mr. Paddock and seconded by Mr. Lake and unanimously favored. The second lowest bidder, Amrex Chemical Co., Inc., at a bid price of \$32,290.50 was approved on a motion by Mr. Lake and seconded by Mr. Paddock and unanimously favored. Funds are available in FX8330.54150.

An award recommendation for the RFP for Repair of Existing Irrigation at Ely Park Municipal Golf Course was awarded to the lowest bidder, Eastern Irrigation & Pump Company, at a bid price not to exceed \$54,000.00 on a motion by Mr. Paddock and seconded by Mr. Lake and unanimously favored.
