A RESOLUTION AUTHORIZING THE MAYOR TO AMEND WORK ORDER NO. 7 WITH GHD CONSULTING SERVICES, INC. FOR THE BAF RESTORATION AND REHABILITATION PHASE AT THE BINGHAMTON JOHNSON-CITY JOINT SEWAGE TREATMENT FACILITY

WHEREAS, the City of Binghamton (the "City") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Facility (the "BJCJSTF") with the Village of Johnson City (the "Village"); and

WHEREAS, the Council of the City of Binghamton adopted Permanent Resolutions R14-058, dated September 17, 2014; R15-031, dated April 8, 2015; R15-106, dated November 4, 2015; R17-50, dated April 19, 2017; and R20-33, dated April 22, 2020, approving a contract and supplemental agreements with GHD Consulting Services, Inc., Work Order 7, Amendment No. 1 to Work Order 7, Amendment No. 2 to Work Order 7, and Amendment No. 3 to Work Order No. 7, Amendment No. 4 to Work Order No. 7, respectively; for engineering consulting services for the restoration and rehabilitation of the BJCJSTF; and

WHEREAS, the Project Manager has recommended that the City enter into an agreement with GHD Consulting Services Inc. for Amendment No. 5 to Work Order 7 to provide \$265,000 for record drawings, \$7,000 for power monitors, and \$5,000 for additional services incidental to the scope of work at a total cost not to exceed \$277,000.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into Amendment No. 5 to Work Order 7, approved as to form and content by the Office of Corporation Counsel, with GHD Consulting Services, Inc. to provide \$265,000 for record drawings, \$7,000 for power monitors, and \$5,000 for additional services incidental to the scope of work at a total cost not to
