AN ORDINANCE TO AMEND THE 2021 BINGHAMTON-JOHNSON CITY JOINT SEWAGE BOARD BUDGET TO SUPPORT THE 2021-2025 CBA FOR THE HOURLY UNION EMPLOYEES

WHEREAS, the City of Binghamton (the "City") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Facilities (the "BJCJSTF") with the Village of Johnson City (the "Village"); and

WHEREAS, the BJCJSTF is operated and maintained by the Binghamton-Johnson City Joint Sewage Board (the "JSB") under a series of inter-municipal agreements between the City and the Village; and

WHEREAS, the Council of the City and the Board of Trustees of the Village approve the BJCJSTF budget; and

WHEREAS, the JSB has requested an amendment to the 20201 BJCJSTF budget to transfer funds needed to support the 2021-2025 CBA for the hourly union employees.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Council approves and directs the Comptroller/JSB Fiscal Officer to amend and make journal budget entries in the 2021 BJCJSTF budget to support the 2021-2025 CBA for the hourly union employees as follows:
