Requested Review:

Curb openings on Gerard Ave in association with the construction of two four-story structures containing a combined 117 dwelling units with 141 total bedrooms and 12,015 ft² of ground-floor commercial space in the C-4 Neighborhood Commercial District. Elizabeth Street will no longer be a public street. Building on Gerard will be a drive-thru business. Jared was concerned about the exit onto Gerard and asked if this been addressed. The design of drive-thru allows up to 8 cars to be stacked without blocking the sidewalk. Gerard is a low volume street. A trip generation rate has not been done yet but one was done for the residential side. There are about 50 entering and 50 cars exiting. There will there be a pedestrian entry from Front Street.

Residents are concerned about cars speeding on Pennsylvania Avenue. The highest speed was 68 MPH. Residents have expressed concern to the Binghamton Police Department and feel that nothing has been done. Residents are also

concerned about having to cross the street to access their mailboxes. There are also are large amount of trucks using the street. Residents are requesting the installation of a speed limit warning system. Jared will look at the weight limit of the street and have the engineers look at the grading of the road. They will also look at traffic counts from BMTS. Finally, they will work with the Binghamton Police Department and the Traffic Division in regards to the speeding. The large trucks are using Vestal Avenue to access 434 passing the elementary school. They feel it is a misuse of road usage. HOLD for July meeting.
