

Markets law; and

WHEREAS, the City wishes to renew the contract with the Broome County Front Street
Dog Shelter for dog shelter services for five (5) years, from January 1, 2022, through December
31, 2027; and

WHEREAS, this agreement may be terminated for any reason by either party as of the end
of any calendar year by delivering written notice to the other party by June of the prior year before
date of termination; and

WHEREAS, the cost for such services is an amount up to \$63,578.02 in 2022, and will
increase by CPI each year.
