AN ORDINANCE TO AMEND THE 2021 CAPITAL FUND BUDGET TO ADJUST THE SERIAL BOND REVENUE LINE FOR NYSDOT GRANT PAY DOWNS THAT WILL REDUCE THE AMOUNT OF BONDS ISSUED AND RECEIVED

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2021 Capital Fund budget to adjust the Serial Bond Revenue line for New York State Department of Transportation ("NYSDOT") grant pay downs that will reduce the amount of Bonds issued and received; and

WHEREAS, these budget amendments were approved by the Board of Estimate and Apportionment on October 20, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:
